



Quality Tool of the Month:	Overview of the U.S. Government Role Food Safety and Quality						
Presented by:	Lydia Berry Lydia recently retired from a 40 year career with the United States Department of Agriculture. A majority of her time was working for the Agricultural Marketing Service performing inspections of processed fruit and vegetable products. As a supervisor, she was responsible for training staff and ensuring uniform interpretation and application of grade standards and department policy. She accepted promotions to headquarters in Washington DC, developing and revising grade standards and tools to assist inspectors, and managed audit programs assessing processors' compliance with FDA current Good Manufacturing Practices (cGMPs).						
Overview:	This short presentation is intended to provide an overview of the U.S. Government's role in food safety and quality focusing on the following questions: What agencies regulate food safety? What is the government's role in food quality? How does the FDA Food Safety and Modernization Act (FSMA) play a role in food manufacturer's food safety programs? FSMA incorporates tools we have recently reviewed, including risk assessment and supplier programs.
